

EDITOR NEEDED

The Pennsylvania Historical Association (PHA) seeks an editor for Pennsylvania History. The editor will be responsible for soliciting, reviewing, and managing manuscripts for the journal; preparing for publication and copy-editing each issue of the journal; maintaining the journal in good order; handling correspondence related to the journal, working with the printer/publisher in bringing out the journal in a timely and efficient manner; reporting on the journal's activity to the PHA; and handling all other regular duties of an editor of a scholarly journal. The editor will work cooperatively with the book review editor, associate editor(s), and editorial advisory board, maintain good relationship and regular communication with PHA officers. The editor receives an honorarium, a small travel allowance and certain office expenses. The Editor's home institution will be expected to provide released time for the editor and other forms of institutional support, which might come in the form of secretarial support, office space, photocopying, and telephone and postage accounts. The position will commence no later than January 2003. Candidates should send a letter of application, including evidence of editorial experience and interest in Pennsylvania and Mid-Atlantic regional history, a current c.v., and at an appropriate time a letter indicating institutional support to Dr. Randall M. Manuscripts must be submitted in three copies and should conform with the Chicago Manual of Style. Notes should be double-spaced and placed at the end of the manuscript. We encourage submission of manuscripts on discs. Please do not mail your discs until we have accepted your article and indicated corrections to be made.

THE LIBRARY COMPANY OF PHILADELPHIA PROGRAM IN EARLY AMERICAN ECONOMY AND SOCIETY

2002-2003 Fellowships

The Library Company of Philadelphia's Program in Early American Economy and Society will award one dissertation fellowship and one advanced research fellowship, tenable for nine consecutive months from September 2002 to May 2003 and carrying stipends of \$15,000 and \$35,000, respectively. The Program will also award four one-month research fellowships carrying stipends of \$1,600, tenable from June 2002 to May 2003.

Designed to promote scholarship on the origins and development of early American business and the economy to roughly 1850, these fellowships will provide scholars the opportunity to use the extensive printed and manuscript collections related to the history of commerce, finance, technology, manufacturing, agriculture, internal improvements, and economic policy-making that are held by the Library Company and by numerous other institutions in its vicinity.

APPLICATION DEADLINE IS MARCH 1, 2002, with a decision to be made by March 31. To apply, send four copies each of a c.v., a detailed description of the nature of the research to be undertaken during the fellowship period, a relevant writing sample of no more than 25 pages, and two letters of recommendation sent by separate mail to: Library Company of Philadelphia, Program in Early American Economy and Society, 1314 Locust Street, Philadelphia, PA 19107. (For one-month fellowships omit the writing sample and the second reference.)
