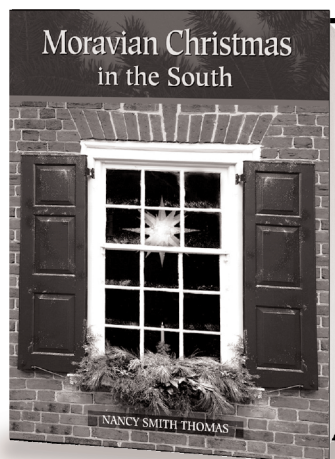

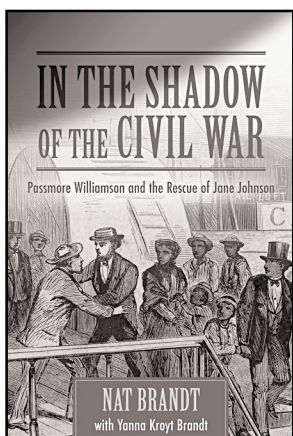

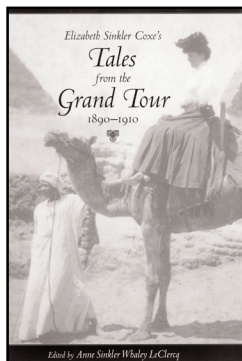

PMHB Online

THE HISTORICAL SOCIETY OF PENNSYLVANIA, in partnership with the History Cooperative and with Penn State University Libraries, has brought *The Pennsylvania Magazine of History and Biography* into the digital age! Soon *PMHB* will also be available through JSTOR.

Current issues, beginning with the January 2006 issue, are available to subscribers of the print edition on the History Cooperative Web site simultaneous with print publication (<http://www.historycooperative.org>). In order to access the History Cooperative's archive, researchers will need to log in using their ID number, which appears on their mailing label.

Back issues of *PMHB*, from 1907 through 1999, are available as part of Penn State University Libraries' developing electronic database in Pennsylvania history (<http://publications.libraries.psu.edu/eresources/pmhb>). Access is open to everyone, and a new volume will be added every year.

The oldest continuously published state historical journal, *PMHB* has been published in print since 1877. Now it is available online, too, making scholarship on Pennsylvania history more accessible than ever.

The Library Company of Philadelphia Long-term Post-Doctoral Fellowships for 2008-2009

The Library Company's National Endowment for the Humanities Post-Doctoral Fellowships support research in residence at the Library Company on any subject relevant to its collections, which cover a variety of fields relating to the history of America and the Atlantic world from the 17th through the 19th centuries. NEH Fellowships are restricted to United States citizens or to foreign nationals who have been living in the United States for at least three years.

The Library Company's Program in Early American Economy and Society (PEAES) Post-Doctoral Fellowships support research into the origins and development of the early American economy, broadly conceived, to roughly 1850, in the collections of the Library Company and other research institutions in the Philadelphia region. PEAES Fellowships are open to scholars from any country.

The stipend is \$40,000, or \$20,000 per semester if the award is divided.

Applicants must hold a Ph.D. by September 1 of the year they wish to take up either fellowship. The fellowships are tenable from September 1, 2008 through May 31, 2009. They may also be divided between two scholars for the periods between September 1, 2008 to January 15, 2009 *or* January 15, 2009 to May 31, 2009.

**THE DEADLINE FOR RECEIPT OF POST-DOCTORAL
APPLICATIONS IS NOVEMBER 1, 2007**, with a decision to be made by
December 15.
