BRIAN C. BLACK is professor of history and environmental studies at Penn State Altoona, where he currently also serves as head of arts and humanities. He is the author of several books, including *Petrolia: The Landscape of America's First Oil Boom* (Johns Hopkins, 2003) and *Crude Reality: Petroleum in World History* (Rowman & Littlefield, 2014), and edited *Nature's Entrepôt: Philadelphia's Urban Sphere and its Environmental Thresholds* (University of Pittsburgh, 2012) and *Climate Change*, a four-volume encyclopedia (ABC-CLIO, 2012), among other titles. He is editor of the Energy and Society book series with West Virginia University Press.

SAMANTHA J. BOARDMAN holds a doctorate in American Studies from Rutgers University–Newark and currently lectures in public history at Rutgers University–New Brunswick. She consults on digital humanities, project management, and research for the Newest Americans and Humanities Action Lab initiatives, and her original research continues to generate a wide variety of archivally based documentary, curricular, and exhibition materials.

LOUIS CARLAT is an associate editor of the Thomas A. Edison Papers, at Rutgers University.

DONNA J. RILLING is associate professor of history at the State University of New York at Stony Brook, where she focuses on the history of the early American republic. She completed her doctoral work at the University of Pennsylvania and is author of *Making Houses, Crafting Capitalism; Builders in Philadelphia, 1790–1850* (University of Pennsylvania Press, 2001). Her current book project examines the metamorphosis of a waterway in nineteenth-century Philadelphia that was at the heart of political, social, and environment conflict.

PETER A. SHULMAN is an associate professor of history at Case Western Reserve University, specializing in nineteenth- and twentieth-century US history, particularly around science, technology, and politics. His recent book, *Coal and Empire: The Birth of Energy Security in Industrial America*, examines how Americans came to think about energy in terms of national security through dealing with coal and, later, oil between the 1840s and 1930s.

JOEL A. TARR is the Richard S. Caliguiri University Professor of History and Policy at Carnegie Mellon University. His research focuses on the intersection between cities, technology, and the environment.

DANIEL WEEKS is an assistant editor of the Thomas A. Edison Papers, at Rutgers University. He is also the author of *Not for Filthy Lucre's Sake: Richard Saltar and the Anti-Proprietary Movement in East New Jersey, 1665–1707* (Lehigh University Press, 2001).

ERRATA: page 189 of the April 2015 issue of *PMHB* contains several inaccuracies regarding the biography of John Cadwalader that have since been brought to the editors' attention. John Cadwalader married twice. His first marriage was in 1768 to Elizabeth "Betsy" Lloyd, of Wye, Maryland. Betsy had three daughters, Anne, Elizabeth, and Maria, but died of complications eleven days after Maria's birth, in February of 1776. John remarried in 1779 to Williamina "Willy" Bond (1753–1837). Together the couple had three children: two sons, Thomas and John (who died in infancy of smallpox), and a daughter, Frances.
