WESTERN REGIONAL WEPAN MEETING MINUTES May 23, 1993 Washington, D.C.

Suzanne G. Brainard, University of Washington, gave a summary of the 1992 Regional Activities. A survey of needs identification was conducted and used to help plan the Western Regional WEPAN Conference. This conference was held in conjunction with the annual Women in Engineering Conference held on the University of Washington campus on April 3, 1993. Letters of invitation to the conference were sent to all engineering schools in the western region. Telephone follow-up calls were also conducted with 28 individuals actually indicating that they would be in attendance. However, only 10 WEPAN individuals actually attended the conference. (It is assumed that the present California budget situation was a factor overriding individual or institution interest.) Although sessions were held for the WEPAN track, the WEPAN group never met per se either formally or informally. Therefore, although the student side of the April 3 conference was a success (over 200 participants), it was concluded that future Western Regional WEPAN meetings should not be held in conjunction with another conference. Technical assistance was given in response to some 60 calls during the past year.

A new executive committee of the Western Region was formed for 1993-94. Suzanne Brainard remains as the Executive Director for the western region. Robby Henes will serve as the Coordinator, with Miriam Maslanik, Carolyn Turbyfill, and Denise Loran serving as members of the committee.

An extended discussion was held to determine when, where, and how the next Western Regional WEPAN meeting should be held. Primary factors in this decision included the depressed economy in California at this time and the need to have time to plan an excellent program. The group decided to hold the next event, the Western Regional WEPAN Training Seminar, in the fall of 1994. Sun Microsystems, located in the Silicon Valley, was discussed as a possible location for the conference. This appears to be a central location and may allow us to utilize a greater number of resources and to attract more people from both industry and academia. A discussion was held on ways industry and academia could work together at this conference. A major goal of both academia and industry is to increase the recruitment and retention of women into engineering. The executive committee will be responsible for planning the conference. Another needs assessment of the region will be designed to help pinpoint the most helpful program for the Fall Western Regional WEPAN Training Seminar. Suzanne Brainard, Jamie Kelley, and Mary Anderson will design and conduct the survey.

In the meantime, an offer letter of support will be sent to all engineering schools in the Western Region. Robby Henes volunteered to draft this letter. She will work with Suzanne Brainard to form the final version. This letter will give basic information about WEPAN, its activities, resource material and how to join, information about the Midwest and Eastern Regional WEPAN Training Seminars, technical assistance, and an announcement on the 1994 Western Regional WEPAN Seminar.

Industry representatives suggested that future brochures for WEPAN events include bulleted items of industry benefits for the support of WEP/WIE programs. These items would help attract industry attention and supply a rationale for industry participation and financial support.

Miriam Maslanik offered to organize an e-mail newsgroup for the Western Region, which can be accessed through internet. This newsgroup will be similar to WISENET, FIST and other public subscription newsgroups. This e-mail network will also be mentioned in the "support letter".

SUMMARY OF MIDWEST REGION ACTIVITIES
