THE MANUSCRIPT AND MISCELLANEOUS COLLECTIONS OF THE HISTORICAL SOCIETY OF WESTERN PENNSYLVANIA

A Preliminary Guide Part One

JOHN W. HARPSTER

THIS Society and its nineteenth-century predecessors were logical, grateful, and occasionally embarrassed, recipients of a variety of historical materials donated by members and friends. Until the Society got its own building in 1914 the vexatious problem of safeguarding donations, even less bulky documents and manuscripts, was solved by storing such materials in the home or office of the secretary or in the temporary quarters in which meetings were held. Apart from some of its own records few early materials remain; the collections of the societies of 1838 and 1843, for example, were destroyed in Pittsburgh's great fire of 1845, and about the end of the century, as was discovered in 1908, the books and papers of the present Society begun in 1879 had been absorbed by the institution in which the Society's meetings were held.¹

Most of the Society's collections, archival as well as museum, were received after this Historical Building was opened, and especially after an addition was completed in 1931. However much the accession of books, newspapers, and museum objects contributed to the need for this addition, acquisition of archival material was less than phenomenal. Although many items in the present manuscript and miscellaneous collections bear the bold identification of the office secretary and librarian, prior to 1931 the archives could be described as "a handful of documents, consisting chiefly of none-too-informative

deeds, commissions, and other papers rightly treasured for their antiquity or associations, . . ."²

Establishment of The Western Pennsylvania Historical Survey at the time the addition to the building was constructed in 1931, with the nucleus of a trained staff working actually if not technically for both the Society and the Survey, made it possible to establish a separate archives section in anticipation of additional manuscript and miscellaneous materials which would be acquired. The modest storage facilities — shelving, manuscript boxes, etc. — were never outgrown by the time the Survey ended in 1936 and the classification and cataloging procedures instituted remained entirely adequate. The inventory of archives issued in 1933 listed the following classification for manuscripts:

- [A] personal papers, or any body of materials, for the most part original documents, that have been produced or accumulated by a given individual incidental to the transaction of his own affairs, public or private;
- organization records, or original minutes, reports, accounts, [B] and other papers of societies, business firms, churches, and other corporate bodies:
- miscellaneous manuscripts, or originals or copies of docu-[C] ments singly acquired by the Society:
- [D] collections, or any body of materials, usually transcripts or reproductions, that have been assembled by an outside collector in connection with the study of a particular subject or the pursuit of some special interest;
- [E] secondary materials, such speeches, articles, compilations, and books in manuscript dealing with historical subjects;
- and inventories, calendars, and other guides to materials of [F] western Pennsylvania interest in other depositories.

In addition to manuscripts the inventory covered maps, printed miscellany, unframed pictures, and cuts.3

During the quarter of a century following the end of the Survey the Society continued to acquire archival material in such quantity that it could no longer be contained within the security storage area reserved for it. Although a new members' room and the Siebeneck

room had been installed on the ground floor in 1959 and the secondfloor lounge and library had been redesigned and redecorated in 1961, no physical changes were made to the archives until 1963. Moreover, it had become impossible because of lack of personnel to process archival material as it was obtained during the war and postwar periods.

An important factor in the decision to bring the facilities of the Society's archives up to date was receipt of a cash bequest granted pursuant to the will of Mrs. Roy Arthur Hunt, a good friend of the Society who had presented manuscript materials to it. With the approval of Mr. Hunt this sum, later increased by action of the Trustees, was authorized for purchase of additional storage equipment and employment of a part-time staff member to survey the archives, plan its expansion, supervise installation of equipment, and literally perform the housekeeping duties attendant upon such expansion. The work was begun in June 1963 but terminated in less than two years because of lack of funds; it has, however, been continued on a voluntary basis.

In that time the security storage area has been increased almost threefold by the installation of new steel shelving and map drawers, and strong manuscript boxes have been provided for all unbound archival material of legal size or less. Oversize bound volumes consisting principally of business records, scrapbooks, and albums have been wrapped in heavy paper and shelved together to conserve space. More important, virtually all previously unprocessed materials have been arranged, classified, cataloged in draft or final form, and stored in orderly fashion; gone are the trunks, suit- and shoeboxes, and japanned "strongboxes" that had accumulated in even leaner days.

The classification scheme instituted for manuscripts in 1931 and quoted from the 1933 inventory above has been retained; a survey of several state historical societies bears out the wisdom of this decision. The nature of archival material other than manuscripts which the Society has acquired, and the desire to record and preserve it, has led to some revision of the classification proposed for miscellaneous collections. This revision need not be considered here inasmuch as the preliminary guide given below consists not only of one class of manuscript, personal papers, designated "A," but with one subgroup of that class, "AA," larger groups of personal papers contained in one or more manuscript boxes. A guide for classification "AB," smaller groups of personal papers, is in preparation.

The latter vol. is filed with the Craig-Neville family papers, below; the former is on permanent display. (Note that the bulk of the Craig papers are at Carnegie Library of Pittsburgh, where a detailed calendar of them is available; duplicates of some of these calendar cards are kept at the Society with the Craig-Neville family papers.)

DENNY-O'HARA FAMILIES.

O'Hara papers consist of account books as a Philadelphia and Pittsburgh merchant, 1779-1819, and business records of his Army contract to provision western posts, 1792-1802. Papers of Pittsburgh's first mayor, Maj. Denny, include correspondence on Indian affairs after the Revolution, a record of the 1st Pennsylvania Regiment, 1785-1785, mayoralty papers, 1816, and two account books. Representative Denny's papers contain political correspondence and clippings, 1829-1837, and three diaries of his travels in the midwest, 1840-1850. Miscellaneous papers include a rent book, 1818-1820, personal papers of Miss Matilda Denny, and genealogical data on the DennyO'Hara-Wilkins families. Noted in WPHM 15: 174 (1932). Consist of a ledger, 1770-1789, "Manuscript book," 1778-1810, and notebook, 1800-1821; typescript list of Morgan papers in The Philadelphia Society for Promoting Agriculture; and copies of a few letters to him once owned by his descendant (including Washington letters unknown to Fitzpatrick). Major items are separately cataloged. Other Morgan papers in Carnegie Library of Pittsburgh have been calendared; some duplicate calendar cards are available at the Society.

Memorabilia include chessmen carved while in prison and photographs in uniform. Many obituary notices are also included.
